Council approval is recommended for the extension of Blanket Contract 506084 with Asplundh Tree Expert Company for Tree Trimming and Right-of-Way Vegetation Management, as needed by the Public Works Department. The estimated annual expenditure under this contract is \$200,000.00 annually.

The award of the blanket contract was originally approved by City Council on October 19, 2010. The City utilized the Electric Power Board's contract #C1070 with Asplundh Tree Expert Company, which was competitively bid, as allowed by TCA 12-3-1004. Dear Chief Dodd:

Council approval is recommended to declare surplus the attached list of Firearms. Twenty-Seven (27) Smith & Wesson semi-automatic pistols, One Hundred Nine (109) Smith & Wesson TSW's (qty. 107 – 4513 and qty. 2 – 45 caliber semi-automatic) pistols. The Police Department would like the guns to be used as a trade-in on new guns to G T Distributors at a credit value of \$35,734.60. These guns are no longer suitable for use in the Police Department.

I recommend the guns be declared surplus by the Council and used as a trade-in on Forty-Nine (49) Bushmaster AR14 M4 Carbine .223 Rifles at a cost of \$35,877.31 this will leave a deficit balance of \$142.71 for the Police Department. We will process the applicable paperwork to transfer the guns after your approval.
