The applicant was present; there was no opposition in attendance.

Jerry Pace of the Planning Agency briefed the Council on this request and indicated that the request is located in the East Brainerd area near Highway 153 and Lee Highway at the intersection of Dupree Road and Lee Highway. He stated the request is for a car care facility. He stated there is commercial development along Lee Highway and an office development in an R-4 area that sits back off the road. He stated that the Staff and Planning Agency recommend approval subject to the condition that driveways on Lee Highway and Dupree Road be widened to 30 feet in width and that the driveway from Dupree Road shall be realigned so that it intersects with the street at 90 degrees. He stated that the Traffic Engineer had indicated that there was some concern due to the dangerous intersection.

Councilwoman Rutherford stated that the packet of information she received this weekend indicated that there was opposition present at the Planning hearing in regard to this request; that five-or-six persons had called-in regarding this. Mr. Pace stated that there was a person in opposition present at the Planning hearing; that the telephone log did not reflect the calls referenced by Councilwoman Rutherford.

Fred Zillich stated that he met with Joe Booth who has recommended approval.

Councilman Eaves asked for clarification as to whether Mr. Zillich had received approval from the Traffic Engineer's department? Mr. Pace stated that Mr. Zillich met with Joe Booth and not the Traffic Engineer. Mr. Zillich indicated that the Traffic Engineer was present at the meeting, also.

Councilman Eaves stated that he would like for the Traffic Engineer to take a look at this; that this is a bad intersection where cars move fast. He made the motion to defer the matter two weeks.
