City Council Building Chattanooga, Tennessee January 16, 2001

Chairman Hakeem called the meeting of the Chattanooga Council to order with Councilmen Crockett, Eaves, Franklin, Hurley, Pierce and Taylor present; Councilmen Lively and Rutherford were absent due to personal commitment. City Attorney Randall Nelson, Management Analyst Randy Burns, and Council Clerk Carol O'Neal, CMC, were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

Following the Pledge of Allegiance, Chairman Hakeem gave invocation.

MINUTE APPROVAL

On motion of Councilman Pierce, seconded by Councilman Franklin, the minutes of the previous meeting were approved as published and signed in open meeting.

RAE YOUNG BOND AND NATHAN RIDLEY

Chairman Hakeem recognized the presence of Rae Young Bond, the newly appointed Executive Director of the Tennessee Municipal League (TML) and Nathan Ridley of Nashville.

Mrs. Bond stated District meetings were held today and there was good discussion regarding issues currently facing TML. She encouraged Council members to communicate with her, expressed thanks for the Council's hospitality and indicated her happiness in having the opportunity to work with the Council in a new effort.

Nathan Ridley stated that he is from Nashville and works for TML on the cities' behalf before the General Assembly; that he is currently attending the District meetings and will continue with others (District meetings) across the State. He urged Council members to communicate with him if there are issues he can assist with, as he is only a call or "e-mail" away.

RAE YOUNG BOND AND NATHAN RIDLEY

Chairman Hakeem stated that Chattanooga is proud of Mrs. Bond in the capacity she is now serving; that she will do as good or better as she has done in Chattanooga and has a first-class staff to work with her, as symbolized in Mr. Ridley. He stated Councilman Franklin, Admin. Boney and he serve on the Board of Directors and that it is important that Chattanooga be involved with TML as it makes a difference when it comes to legislation that may impact Chattanooga, particularly financially.

Admin. Traughber stated that this Resolution should be "pulled"; that this property, along with several others that are owned by the City, is part of a discussion in regard to the location of a new school in the M.L. King area that will be located on East Eighth Street. He stated until such time as an agreement with the entities involved is settled, Administration is not going to make a determination. He stated the Council adopted a Resolution in 1999 regarding this property for donation to ICDC, yet, two months ago the County Commission passed a document to donate the property to the U C Foundation for Phase II housing. He stated since that time, discussion has been held regarding the location of a school and housing and there needs to be a "meeting of the minds" with entities. He stated it is hoped this can be done within the next two weeks or thirty days.

Councilman Pierce asked if this property is part of the bond request? Admin. Traughber stated that the same question was asked in a meeting he did not attend; that the bond issue is not one that is "on the table" at this time. He stated the plan is to try to resolve the matter within two weeks and, if not, someone will have to be a referee regarding the decision.

HEARING: SHAWN HICKEY

City Attorney Nelson reminded Council members of the hearing for Officer Shawn Hickey scheduled for Monday, January 22 beginning at 4 p.m. with Councilmen Hurley (Chair), Lively and Franklin as the panel hearing the request.

COMMITTEES

Councilman Taylor stated a meeting of the Budget and Finance Committee was held earlier in the afternoon for a briefing on the Capital Budget.

Councilman Franklin reminded Council members of the meeting of the **Parks** and Recreation Committee scheduled for Tuesday, January 23 at 4 p.m.

Councilman Crockett scheduled a meeting of the Legal and Legislative Committee for Tuesday, January 23 immediately following the Parks and Recreation Committee meeting to discuss a Resolution for legislation regarding home invasions.

MISTY MURRAY

Misty Murray, General Manager of the Residence Inn in downtown Chattanooga, spoke on behalf of the management association that owns the Inn and the Courtyard by Marriott that is under construction (in the downtown area). She expressed concern regarding the back of visibility of police in the Aguarium district and near the new hotel that is under construction with regard to the number of panhandlers on the street and the gangs of kids that has become alarming and numerous. She inquired as to where the Bicycle Police Patrol is and the Policemen that were on horseback; that three years ago she saw policeman all the time in the downtown area and each year it has become worse in regard to the non-visibility of officers. She stated that it was her thought that when the new downtown precinct opened she would see uniformed officers on the street, however, that has not happened. She stated that she has to pause before sending families, especially mothers with children and single women, out for sightseeing in the downtown area, as she does not want them approached by these people. She stated some have become aggressive and follow guests back to the hotel for handouts, which is not the image that needs to be presented for Chattanooga. She stated persons visiting the City help the City grow and she is concerned about their safety. She again inquired as to where the policemen are in the downtown Aquarium district?

Chairman Hakeem inquired as to whether the guests of Ms. Murray's hotel have experienced an incident of harm? Ms. Murray responded "no"; that it is just the matter of being approached and persons being scared. She stated during the summer months children run through the lobby, grab things and run out the front door.

Chairman Hakeem stated City government has been very active in trying to find positive things for people to do; that the Parks and Recreation Department has gone far beyond what has taken place in a number of cities to ensure that visitors will have much to do in our City. He stated though there is a problem and it is something that needs to be looked into, he is thankful that there has not been any harm to anyone, which says something about our City, also.

Chief Dotson stated that this is his first knowledge of the matter and indicated that the Downtown Precinct is very active and aggressive in working with merchants. He stated Lt. Freeman Cooper is very community-minded and any time any of the merchants have a concern he is there to deal with it and get it resolved.

MISTY MURRAY (Continued)

Chief Dotson reiterated that this is his first knowledge of the matter and would bring it to the attention of Lt. Cooper; that there are more police visible in the downtown area per square mile because there is not as much mileage (downtown) as in other neighborhoods.

Chairman Hakeem inquired as to whether it is possible for Lt. Cooper to communicate with Ms. Murray? Ms. Murray indicated that she placed a call to Lt. Cooper and has not received a return call.

Councilman Crockett stated that the homeless persons do bother people, particularly single females; that there is a group that regularly moves from one end of downtown to another.

Chairman Hakeem stated that Chattanooga is a progressive City where people want to come visit; that he does not know of a major city where there is not concern about people who are on the streets. He stated while the City affords locations for people to receive food, clothing and shelter, he does not know if we have any more of a problem than anyone else, reiterating that he is thankful there has been no harm toward anyone.

Chief Dotson stated court officers have made arrests and sometimes the Court turns these people back on the street; that he knows there is a concern regarding this issue, yet there is a concern when it comes to profiling of different racial and ethnic groups, which is something that all should be aware of and sensitive to. He stated merchants have been talked to with regard to the same persons coming back into their stores; that the Courts have turn them back on the streets and it is like a "revolving door".

Councilman Crockett asked if Chief Dotson is referring to City Court? Chief Dotson responded, "some are in Sessions Court".

SISTER BEY

Sister Bey stated Council members claim so much is being done in neighborhoods and made reference to a neighbor's house that is being sold for back tax property due to CNE's non-purchase. She expressed concern about the Citico Project and "orders" from HUD to "fix them up"; that people are getting tired and does not want the City "messing in their neighborhoods".
