Vice Chairman Pierce called the meeting of the Chattanooga Council to order with Councilmen Benson, Hakeem, Page, Rico and Rutherford present; Councilmen Bennett and Franklin were in attendance at the National League of Cities Convention in Charlotte, North Carolina; Chairman Robinson was absent due to personal commitment. City Attorney Randall Nelson, Management Analyst Randy Burns and Council Clerk Carol O'Neal, CMC, were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

Following the Pledge of Allegiance, Councilman Page gave invocation.

MINUTE APPROVAL

On motion of Councilman Hakeem, seconded by Councilwoman Rutherford, the minutes of the previous meeting were approved as published and signed in open meeting.

REZONING

2005-176: Phil Shellabarger

Councilman Pierce stated this matter came before the Council four weeks ago and the community has worked on this. He stated there is an agreement with Mr. Shellabarger that he would bring back a site plan and divide the parcel up so it could be zoned within guidelines of the land use plan for a change to O-1. He asked Mr. Pace if he had met with Mr. Shellabarger.

Jerry Pace, Director of Development Services with the Regional Planning Agency (RPA), stated that he has not met with Mr. Shellabarger and clarified that there are two tracts of land involving this request and rezoning would take place on one of them, however there was no previous motion on that.

Chief Cooper explained that this is not the normal way; that it is "behind the curve." He stated this would provide for covert vehicles to be used by narcotics and are being purchased with narcotics funds, not capital funds by any means.

Councilman Hakeem stated that he thought previously confiscated cars were used for this purpose and it was his thought there is a lot full of cars out there.

Chief Cooper responded "no"; that that is not usually available and never always available. He stated this way narcotics can buy the cars they need to do covert and undercover work; that they trade and buy other cars when they are not longer useable. He stated this is always done through the Council and it is dictated annually how many cars the department would be allowed to buy.
