Job Training and Certification Project

Councilman Hakeem asked for the Council's consideration of a project that he has been discussing at various meetings with community leader James Moreland and First Things First. The forerunner of this new project, he said, is the "My Brother's Keeper" project, which targets ages 16 – 24. This new project will target men ages 24 -40 who need to be prepared for the workforce. He is asking the Council to be a "champion of the project" in helping to move it forward. It would be a training and certification project that could help reduce crime and other challenges affecting men in this age group.
