LEGISLATIVE COMMITTEE MINUTES

January 17, 2023

Call to Order

Councilman Ken Smith, Committee Chair, called the meeting to order at 3:54 p.m. in the Assembly Room of the John P. Franklin, Sr. City Council Building. A quorum of the Chattanooga City Council was present, including Council Chairman Darrin Ledford, Vice Chair Raquetta Dotley, and Council members Chip Henderson, Jenny Hill, Carol Berz, Marvene Noel, Demetrus Coonrod, and Isiah Hester. Approval of Minutes

City Election Cycle Legislation
