CHATTANOOGA POLICE ADVISORY AND REVIEW COMMITTEE QUARTERLY REPORT PERIOD COVERED: JULY, AUGUST, and SEPTEMBER 2022

I. CASE STATISTICS:

- a. PARC reviewed 62 cases involving 77 officers.
- b. Breakdown Citizen v. Internally Generated Complaints
 - i. 36 Citizen Generated Complaints
 - 1. In 5 of the cases generated by a citizen complaint, the Chain of Command (COC) and PARC found at least one violation of policy by one officer.
 - ii. 26 Internally Generated Complaints
 - 1. In 19 of the cases generated internally, the COC and PARC found at least one violation of policy by one officer.
- c. From October 2020-September 2022, PARC has reviewed 346 cases involving 422 officers. In 20 of those cases the Chief's final decision was different from the PARC recommendation (in some instances the Chief only disagreed on one of the policies, or the Chief found a violation where PARC did not, etc.)

Chris Sands, *Interim Executive Director* Community Safety and Gun Violence Prevention The Mayor's Roadmap to End Gun Violence in Chattanooga asserts that gun violence is a public health crisis that is threatening the health and well-being of our city. To move toward a solution, the Office of Community Health charged its Community Safety & Gun Violence Prevention division to work on a comprehensive plan that models intervention and prevention.

We *intervene* to stop the current cycle of gun violence *and* invest in long-term initiatives to *prevent* it from returning.

Together we can change the trajectory of our children and youth through well planned intervention and prevention initiatives. We also will continue to provide assistance to older individuals with initiatives like our New Life Job Fair event, weekly client visits to CADAS, and being available to CPD when a victim or witness to a crime needs our immediate attention.

With the onset of the pandemic, it became evident that teens had also been dealing with mental health issues and daily trauma.

The medical community tells us that youth's brains are not fully developed until they are in their mid 20s.

They are not small adults. Instead of calling them juveniles we need to call them what they are...

- Provide social service support to at-risk individuals
- Assist 30 CADAS clients with social services, employment, and life motivation tools; perform intake and assessments
- Coach clients to meet their needs and achieve their goals
- Train those serving youth in mental health enrichment

Reaction (Crisis Response)

- Assist victims in providing detailed information, evidence, and testimony about crime to law enforcement officials
- Utilize Witness Support and/or Big Small Stuff funds to support the witnesses/victims in times of emergency





Prevention cont'd

According to the **Centers for Disease Control and Prevention**, youth mentorship is one of the most effective strategies for reducing violence. It is for this reason we partner with HCDE to:

- Monitor hallway and lunch time at Howard School and Tyner School
- Read weekly with targeted groups of 3rd and 5th grade male students at Bess T. Sheppard Elementary
- Volunteer with Reality Check at Hixson High School

What We Learned

- Students want continued safe spaces, career opportunities, and more mentors. They want adults to listen to them and not talk **at** them.
- Students were able to have positive interactions with CPD.
- Many of the parents are the working poor, looking for support
