STRATEGIC PLANNING MEETING RECAP – JUNE 15, 2021

- I. <u>Call to Order</u>: Chairman Henderson called the meeting to order at 2:00 p.m. A quorum was present that included Councilpersons Berz, Coonrod, Dotley, Hester, Hill, and Ledford. Councilpersons Smith and Byrd were not present at this meeting. Phil Noblett, Deputy City Attorney, and Nicole Gwyn, Clerk, were also present. Two members of the media were present.
- II. <u>July 20th Council Meeting</u>: Chairman Henderson informed the Council that he and the Vice-Chair would not be present at the meeting on 7/20. Therefore, he asked the Council if they would like to go through the process of electing a Chairman Pro Tempore or cancel the meeting. The Council came to the consensus to cancel the meeting on 7/20. Chairman Henderson instructed the Clerk to ensure the public notification of the meeting cancellation.
- III. New Council Committees: Chairman Henderson proposed the list of standing committees and his recommendations for committee chairs (*see attached*). Upon consensus, the Council accepted the Chairman's recommendation for committees and chairs. Mr. Noblett will prepare a resolution to amend the Council's Rules of Operation.
- IV. <u>Council's Plan of Work Goals and Legislative Strategies</u>: Councilwoman Berz discussed the need for developing legislative strategies. Discussion ensued with Councilpersons Coonrod, Hester, Ledford, and Hill also making comments.

- VI. Park Fee Waiver: Travis Kazmierzak discussed the park fee waiver process and the OS-PACE program for smaller events. He distributed presentation handouts to the Council and discussed the Year 1 and Year 2 data. He responded to questions about the purpose of the program, measuring impact, ensuring an "equitable" process, maintaining the grounds, and ensuring equal treatment of all people at the events. Councilwoman Hill recommended that the Council establish shared definitions, such as a shared definition of the word "equity."
- VII. <u>Wastewater Facilities Tour</u>: Councilwoman Hill had previously scheduled a tour with the Wastewater Division. She will forward her invitation to the rest of the Council.
