# **STRATEGIC PLANNING MEETING RECAP/MINUTES – October 4, 2022**

- I. <u>Call to Order</u>: Chairman Ledford called the meeting to order at 1:00 p.m. A quorum was present that also included Councilpersons Carol Berz, Demetrus Coonrod, Chip Henderson, Isiah Hester, Jenny Hill, Marvene Noel, and Ken Smith. Vice Chair Dotley arrived later in the meeting. Also present were Emily O'Donnell, City Attorney, and Nicole Gwyn, Council Clerk.
- II. <u>Minutes Approval</u>: On motion of Councilman Smith and seconded by Councilman Henderson, the minutes of the last meeting (September 20, 2022) were approved as published.
- III. Land Bank Authority (1 seat available)
  - A. <u>Nominees</u>: Stuart Wasilowiski (Hill) and Emerson Burch (Coonrod) had already been nominated at previous meetings. Councilwoman Coonrod nominated two more individuals expressing interest to serve: Becky Cope English and Donna Williams. She distributed the resume for Ms. English in the meeting and offered to request the resume from Ms. Williams for Council consideration.
  - B. <u>Process</u>: A discuss ensued about the process for narrowing down nominees for the one Council seat. Jermaine Freeman advised that someone would need to be appointed by December. After all discussion, Chairman Ledford scheduled the Council to verify the process and decide on a nominee at the 10/18 Strategic Planning meeting. He set the appointment resolution for the 10/25 Council agenda.
