CHATTANOOGA CITY COUNCIL J.B. COLLINS CONFERENCE ROOM OF THE COUNCIL BUILDING <u>STRATEGIC PLANNING MEETING</u> <u>MINUTES/RECAP – January 17, 2023</u>

- I. <u>Call to Order</u>: Chairman Darrin Ledford called the meeting to order at 2:00 p.m. A quorum was present that also included Vice Chair Raquetta Dotley and Councilpersons Chip Henderson, Jenny Hill, Isiah Hester, Carol Berz, Marvene Noel, and Demetrus Coonrod. Councilman Ken Smith was not present. Attorney Phil Noblett was also present and Council Clerk Nicole Gwyn were also present.
- II. <u>Minutes Approval</u>: Vice Chair Dotley moved to approve the minutes of the last meeting (December 20, 2022). Councilman Hester seconded. The motion carried.
- III. Existing Duplexes/Power Loss Protection: Dan Reuter, Planning Director, discussed the proposed changes to the current resolution to allow power to remain on after the 100 days of a property being vacant. He informed the Council of the report done and fuel survey (distributed during the meeting to the Council). Discussion ensued with Councilman Henderson asking questions on HPR Real Estate and affordable housing. Chris Anderson, Senior Advisor for Legislative Initiatives, and Jermaine Freeman, Senior Advisor for Economic Opportunity & Interim Administrator, joined the discussion regarding affordable housing and vacant duplexes. Mr. Reuter discussed other programs needing to be put in place. Councilwoman Hill informed the Council that the matter was unanimous at the Planning Commission. Councilwoman Coonrod commented on nontraditional routes to homeownership.
- IV. <u>C-2 Amendment</u> (Henderson): Mr. Reuter advised the Council that Planning was still working on the overhaul to the Zoning Ordinance. He informed the Council of a C-2 amendment in response to upcoming hotel/motel conversions changing the uses. He discussed a change to the minimum lot size restriction (residential, single-family) for dwellings in C-2.

 - Section C (page 3-4): Add Affordable Housing Committee to the list of committees with the description that is currently posted on the <u>committee's web page</u>.

- 3. <u>Section A1</u> (page 4): Change Strategic Planning from "each Tuesday" to meeting on the "first and third Tuesday" of each month.
- 4. <u>Section B1</u> (page 5): Add the word "proposed" business agenda (Berz)
- 5. <u>Section B1(c)</u> (page 5): Add language to specify what "under certain circumstances" means when two members of the Council can waive the requirements add agenda items.
- 6. Section B1(c) (page 5): Add language to "remove" agenda items as well.
- 7. <u>Section B2</u> (page 5): Substitute Section 2b with the information in Section 4 regarding the time limits for holding public hearings.
