CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING

COUNCIL CONFERENCE ROOM Recap – 4/5/16

I. <u>Call to Order:</u> Chairwoman Berz called the meeting to order at 1:35 p.m. A quorum was present, including Chair Berz and Councilmen Gilbert, Grohn, Hakeem, Henderson and Mitchell. The assigned attorney was Mr. Hinton. Mayor's staff included Ms. Richardson, Ms. Sullivan and Mr. Carmody. Other staff were Ms. Williams, Mr. Jennings, Mr. Messner, Mr. Noblett, Ms. Gober and Ms. Hayes. Council staff present was Ms. Gwyn. Press present was Mr. Wilson, Mr. Strickland and Ms. Spirato. Mr. Evans, community member, was also present. Councilmen Anderson, Freeman and Smith arrived after the call to order.

 - Illegal Tire Dumping Mr. Hinton
 - Maximum Occupancy in R-1 Zoning Mr. Hinton is focusing on the definition of a boarding house and is working on recommended guidelines for communities.
