CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING

COUNCIL CONFERENCE ROOM Recap - 4/26/16

I. <u>Call to Order:</u> Chairman Freeman called the meeting to order at 1:30 pm. A quorum was present, including Councilmen Anderson, Gilbert, Hakeem, Henderson, Mitchell and Smith. Councilwoman Berz arrived after the call to order. Councilman Grohn was not present. The assigned attorney was Mr. Noblett. Mayor's staff included Ms. Richardson, Ms. Sullivan and Ms. Cooper. Other staff were Chief Fletcher, Mr. Carmody, Ms. Williams and Ms. Gober. Council staff present was Ms. Gwyn. Press present was Mr. Wilson and Mr. Leach.

I. Special Presentations:

- 1. CPD Update: Chief Fletcher updated the Council on the recent "enhanced posture" of the CPD that resulted in 174 custody arrests (of which 44 were gang members) and removed 19 guns from the streets. He also discussed CPD's traffic focus. Councilman Hakeem recommended a letter of thanks from the Council to CPD's federal partners.
- 2. Tiny House Demonstration: Jeremy Weaver, a fellow at Causeway, brought his tiny house for the Council to tour. He has been building tiny houses for two years and is looking into developing a community of tiny houses in the M.L. King or Southside areas. He responded to questions from the Council on the following: taxes, sewer taps, target residents and target date.

[The Council took a 10 minute break to tour the house.]
