 - Coonrod <u>Exclude</u> all of Glenwood: from Laramie, McCallie, Dodson, right from Citico to Chamberlain, left from Glenwood to North Crest, Shallowford Road and McCallie ramp to Lawry;
 - Coonrod Add Missionary Ridge Neighborhood association boundaries;
 - o Gilbert Exclude all of District 5 north of Wilder Street;
 - Oglesby <u>No changes</u> needed;
 - o Mitchell Wants a grandfather amendment first, then add Stuart Heights, if amended.

During the discussion, Councilman Henderson distinguished between long-term vs. short-term rentals, and owner-occupied vs. non-owner occupied properties. Councilman Ledford questioned enforcement and the direct stream of income. Councilwoman Berz also questioned "people" enforcement. Mr. Hinton offered to speak with Ms. Williams about the manpower needed for enforcement. Councilwoman Berz also questioned the costs of the STVR District, and what fees will be covered for that.
