## CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING COUNCIL CONFERENCE ROOM

## 6/27/17 Recap

I. Call to Order: Vice-Chairman Smith called the meeting to order at 1:45 p.m. A quorum was present, including Council members Byrd, Coonrod, Gilbert, Henderson, Ledford and Oglesby. Councilwoman Berz arrived after the call to order. Chairman Mitchell was not present. The assigned attorney was Mr. Hinton. Council staff present was Ms. Gwyn. Mayor's Office staff included Ms. Sullivan, Mr. Sammon, Ms. Cooper and Ms. Newton. Other staff included Mr. Bridger, Ms. Williams, Mr. Stone, Ms. Haley, Mr. Reisman and Ms. Harmon. Media present was Mr. Leach. There were four community members, including Ms. Roderick, Dr. Holmes and Ms. Burns-Sharp.

## II. Old Business

  - 2. Short-Term Vacation Rental Overlay (6/27)
    - a. Councilman Henderson informed the Council that he intends to go back to the original urban overlay, as mutually agreed upon by the Council a few weeks ago. He also confirmed for Councilman Gilbert that District 5 was still not included in the overlay, as agreed upon previously. Councilwoman Berz requested that LDO notify the Council whenever there is an application for a STVR; Ms. Williams agreed. Councilwoman Coonrod asked Mr. Hinton about the funds from STVR earmarked for the waterfront bonds, and how much was still owed on those bonds. Mr. Hinton agreed to speak with the city's bond counsel about the revenue bonds.

This would be in addition to the advertised hearing tonight at 6:00 p.m. Vice-Chairman Smith also reminded the Council that those for and against the ordinance will have 9 minutes allotted at the hearing tonight. Mr. Bridger agreed to give an overview for the public. Councilman Henderson agreed to make comments about the original urban overlay being put forth tonight.
