## CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING COUNCIL CONFERENCE ROOM 7/18/17 RECAP

I. Call to Order 1:30 p.m.: Chairman Mitchell called the meeting to order at 1:30 p.m. with a quorum present, including Vice-Chairman Smith and councilpersons Berz, Byrd, Gilbert, Ledford and Oglesby. Councilwoman Coonrod arrived later. Councilman Henderson was not present. The assigned attorney was Mr. Hinton. Council staff present was Ms. Gwyn. Mayor's staff attending the meeting were Ms. Richardson, Ms. Sullivan, Mr. Sammon and Ms. Cooper. Other staff members attending were Ms. Madison, Mr. Bridger, Ms. Williams, Ms. Harmon and Ms. Manlove. Media present included Mr. Leach. Ms. Burns-Sharp, community member, was present.

- A. RPA Area Plan Process: Mr. Bridger explained the need to update area plans and to connect land use with transportation. He also distributed maps for areas of development intensity, then detailed the strategy of consolidating and dividing into 12 area plans instead of 44. He distributed maps of the 12 areas and discussed how these plans work with current zoning districts/overlays.
