CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING COUNCIL CONFERENCE ROOM

10/24/17 RECAP

I. Call to Order: Chairman Mitchell called the meeting to order at 1:30 p.m. with a quorum present, including Vice-Chairman Smith and councilpersons Berz, Byrd, Gilbert, Henderson, Ledford and Oglesby. Councilwoman Coonrod joined the meeting after the call to order. The assigned attorney was Mr. Hinton. Council staff present was Ms. Gwyn. Mayor's staff attending were Ms. Richardson, Mr. Sammon and Ms. Cooper. Other staff members attending were Ms. Madison and Ms. Harmon. Mr. Wilson, a member of the Media, and Ms. Burns-Sharp, community member, were also present.

 - 1. Agenda Item VII(a): Ms. Richardson informed the Council that this item would be discussed in ECD Committee by Mr. Holland since the agreement began when the Real Property division was under Public Works.

- 1. TIF Review Committee: Ms. Richardson discussed the need for two applicants for an upcoming TIF application. Discussion ensued among the Council about the need to develop a pool of TIF review appointees. Ms. Richardson agreed to send a 1-sheet for appointees.
- 2. BFO Kick-off Info Session: Chairman Mitchell informed the Council about an upcoming training session for employees and nonprofit partners. Councilwoman Berz requested something that she could eblast to her constituents. Ms. Gwyn agreed to provide her with something.
- 3. Pending Legislative Matters:
 - a. Annexation and De-annexation Petitions
 - 1) Mr. Hinton informed the Council that the annexation petition would go to the Planning Commission in November, so no hearing was needed today before the Council.
 - 2) During a discussion on procedure for the de-annexation petition, the Council agreed on a 5-minute time limit per speaker.
 - 3) Councilwoman Berz requested a cost-benefit analysis for the de-annexation.
 - b. Fair Housing Mr. Hinton informed the Council about the source of payment (e.g., housing vouchers) being added to city code to stop this type of discrimination. He clarified how the code would be changed so that the sole determination for not moving forward with an applicant could not be "source of income." Councilwoman Berz requested that sexual orientation be added to the legislation. Mr. Hinton agreed to check on that for her.
