CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING COUNCIL CONFERENCE ROOM 12/5/17 RECAP

I. Call to Order: Chairman Mitchell called the meeting to order at 1:30 p.m. with a quorum present, including councilpersons Berz, Byrd, Coonrod, Gilbert, Henderson, Ledford and Oglesby. The assigned attorney was Mr. Hinton. Council staff present was Ms. Gwyn. Mayor's staff attending were Ms. Sullivan, Ms. Cooper and Ms. Bell. Other staff present was Ms. Harmon. Ms. Walton, a member of the media, was present. Community members present included Mr. and Mrs. McCallie. Vice-Chairman Smith arrived after the call to order.
