## COUNCIL CONFERENCE ROOM 10/30/2018 RECAP

- I. Call to Order 1:30 p.m. by Chairman Smith. A quorum was present, including Councilpersons Berz, Byrd, Coonrod, Gilbert, Henderson, Ledford and Mitchell. Vice-Chairman Oglesby was not present this meeting. The Assigned Attorney was Mr. Noblett.
