## CHATTANOOGA CITY COUNCIL STRATEGIC PLANNING MEETING J.B. COLLINS CONFERENCE ROOM 07/02/19 RECAP

I. Call to Order: The meeting was called to order at 1:30 p.m. by Chairman Oglesby. A quorum was present, including Vice-Chairman Henderson and Councilpersons Coonrod, Gilbert, Ledford, Mitchell and Smith. Councilpersons Berz and Byrd joined the meeting after the call to order. The assigned attorney was Mr. Noblett. Council staff present was Ms. Gwyn. Mayor's staff attending was Ms. Richardson, Mr. Hayes, Ms. Sullivan, Mr. Sammons, Ms. Albright and Ms. Lowdermilk. Other city staff attending was Ms. Madison, Ms. Jackson, Ms. Malueg and Ms. Green. There were also three community members and two members of Media in attendance.
