

ORDINANCE NO. 11471

AN ORDINANCE REAPPORTIONING THE NINE (9)  
DISTRICTS FOR CITY COUNCIL.

---

WHEREAS, Section 19 of the Court Order in the case of *Brown v. Board of Commissioners of the City of Chattanooga, Tennessee*, No. Civ-1-87-388, in the United States District Court for the Eastern District of Tennessee, requires that following publication of each new official decennial federal census, the Council shall reorganize and adjust by Ordinance the boundaries of the council districts; and

WHEREAS, The same section requires that the adjusted districts shall be as equal in population as practicable; and

WHEREAS, The City has now received the official results of the 2000 decennial federal census and is therefore required to redistrict;

NOW, THEREFORE,

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the nine (9) districts for City Council positions be and are hereby reapportioned and redistricted so as to provide that the following districts are hereby established for the various council positions:
