SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned the 1000 block of Cowart Drive and John Mark Road, more particularly described below and as shown on the map attached hereto and made a part hereof by reference:

Abandonment of the 1000 block of Cowart Drive beginning on the east line of the 5100 block of Winding Lane thence 1080 feet southeast to the west line of the 5500 block of Highway 153. Said Drive separates Lots 1 thru 9, Revised Plan of the Leonard Hamil Subdivision, Plat Book 21, Page 96, ROHC and an unplatted tract of land located at 5525 Highway 153 from Lots 16 thru 24, Revised Plan of the Leonard Hamil Subdivision, Plat Book 21, Page 96, ROHC, and an unplatted tract of land located at 5531 Highway 153. Tax Map 99L-D-009 thru 017 and 99L-E-001 thru 010.

Abandonment of the 1000 block of John Mark Road beginning on the east line of the 5400 block of Winding Land thence some 1100 feet southwestwardly to the 5500 block of Highway 153. Said street separates Lots 69 thru 73 from Lots 59 thru 63 and Lots 75

thru 79, Overall Plan of Northern Hills Subdivision, Plat Book 21, Page 51, ROHC. Tax Map 99L-D-001 thru 008.


