AN ORDINANCE CLOSING AND ABANDONING A PORTION OF THE EASTERN RIGHT-OF-WAY OF THE 1100 BLOCK OF LINDSAY STREET, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP AND DRAWING ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned a portion of the eastern right-of-way of the 1100 block of Lindsay Street, more particularly described below and as shown on the map and drawing attached hereto and made a part hereof by reference:

Abandonment of a portion of the eastern right-of-way of the 1100 block of Lindsay Street beginning at a point some 110 feet north of its intersection with the north line of the 1100 block of Houston Street thence continuing northwest some 35 feet, thence southwest some 10.85 feet, thence southeast some 35 feet to the point of beginning. Tax Map 145E-B-009.01.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to Tennessee-American Water Company and AT&T Southeast maintaining their easements in and retention of all utility easements and routing rights for the full width

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.
