AN ORDINANCE CLOSING AND ABANDONING AN ALLEY LOCATED IN THE SOUTH LINE OF THE 2700 BLOCK OF EAST 17<sup>TH</sup> STREET, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP AND DRAWING ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned an alley located in the south line of the 2700 block of East 17<sup>th</sup> Street, more particularly described below and as shown on the map and drawing attached hereto and made a part hereof by reference:

Abandonment of an unopened alley beginning on the south line of the 2700 block of East 17<sup>th</sup> Street thence southwest some 260 feet to the north line of the unopened portion of the 2700 block of East 18<sup>th</sup> Street. Said alley separates Lots 32 thru 36 from Lots 37 and 38, Block 2, Gobel's Subdivision of Blocks 1, 2, 3 and 4 of the Dodds Place, Plat Book 2, Page 13, ROHC. Tax Map 156F-F-008 thru 011.

SECTION 2. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.

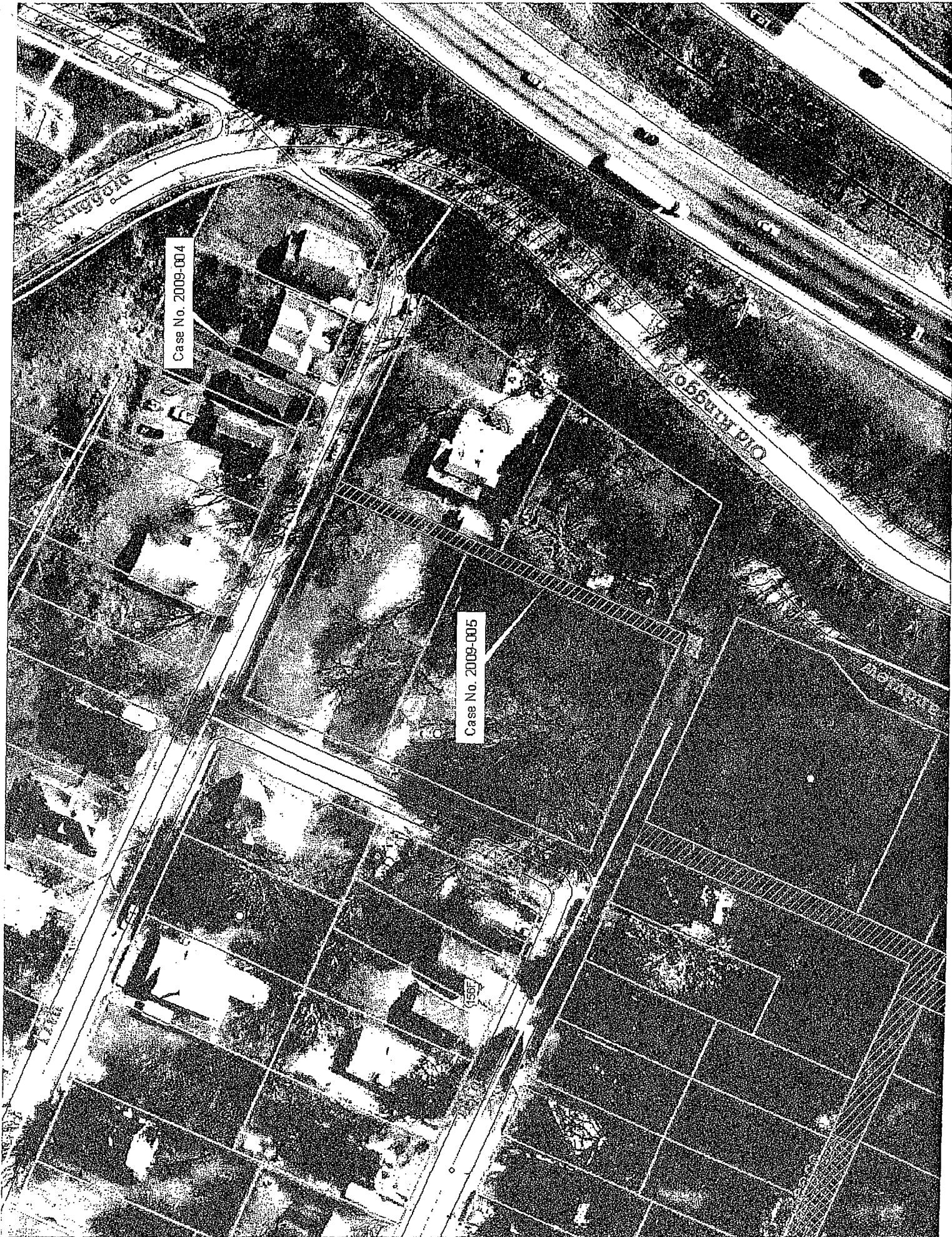

Alley @ the south line of the 2700 block of East 17<sup>th</sup> Street  
Recommendations for Requested ROW Abandonment

---

I have completed the review of Tammy Hass's request regarding abandonment of the right of way more particularly the alley beginning at the south line of the 2700 block of E. 17<sup>th</sup> Street. (Please see attachments). My comments are as follows:

- The existing width of the right of way is approximately 10' ± in width and approximately 257' ± in length.
- This alley's currently designated unopened and unmaintained.
- The applicant owns the adjoining properties.

After review of the Abandonment request, maintaining the above referenced right-of-way does not serve the Public's interest.

Therefore, I recommend the following:
