ORDINANCE NO. 12901

AN ORDINANCE CLOSING AND ABANDONING PART OF THE UNNUMBERED BLOCK OF GRACE STREET BEGINNING AT NORTH CREST ROAD AND GOING NORTH APPROXIMATELY 203.19 FEET AND ENDING AT THE SOUTHERNMOST EDGE OF THE PREVIOUS CLOSURE APPROVED BY ORDINANCE NO. 9336, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That part of the unnumbered block of Grace Street beginning at North Crest Road and going north approximately 203.19 feet and ending at the southernmost edge of the previous closure approved by Ordinance No. 9336, more particularly described herein, and as shown on the maps attached hereto and made a part hereof by reference, be and are hereby closed and abandoned:

Abandonment of part of the unnumbered block of Grace Street beginning at North Crest Road and going north approximately 203.19 feet and ending at the southernmost edge of the previous closure approved in Ordinance 9336. Tax Map Nos. 137H-G-026, 027, 028, 029 & 029.01 and 139H-H-011, 012, & 013.

SECTION 2. BE IT FURTHER ORDAINED, That this abandonment shall be subject to the recommendation of the Planning Commission and subject to the retention of a full-width utility easement for the said utility.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two  
(2) weeks from and after its passage.

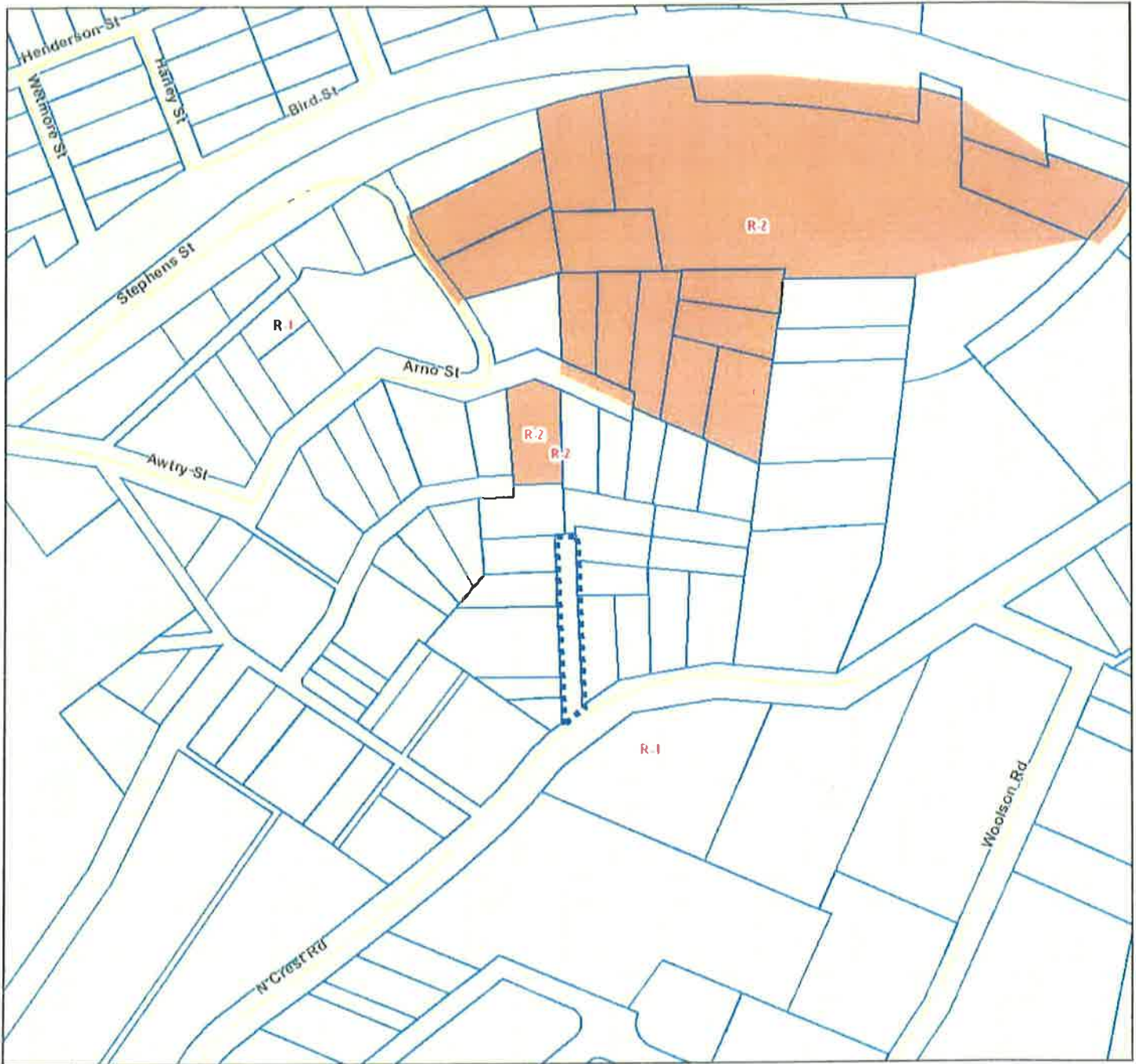
