ORDINANCE NO. 13319

AN ORDINANCE AMENDING CHATTANOOGA CITY CODE, PART II, CHAPTER 26, SECTIONS 26-26, 26-27, 26-34, AND 26-35, RELATIVE TO FEE CHANGES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE:

SECTION 1. That Chattanooga City Code, Part II, Chapter 2, Sections 26-26, 26-27, and 26-34, be amended by substituting the following:

**Sec. 26-26. - Summer Day Camps.**

The following rates shall apply to summer day camp events held at city facilities:

<b>DAY CAMP FEES</b>	
Youth Summer Camp and Kidz Camp (8 weeks)  NOTE: All Hamilton County residents are free and given priority-based upon availability and center capacity.	FREE
Kidz Camp (8 weeks) (Non-Residents)	\$240.00

**Sec. 26-27. - Sports Programs and Field Charges.**

The following rental rates shall apply to use of Washington Hills Football Field facilities:

<b>Washington Hills Football Field Rentals</b>	
Semi-Pro Games	\$200
High School Games	\$200
Middle School Games	\$100
Youth League Games	\$100

**Sec. 26-34. - Arts and Civic Center Rentals.**

The following rental rates and fee schedule shall apply to events held in City arts and civic centers.

1) **Heritage House**

<b>Hours of Operation (Daily 8:00 a.m. to 11:00 p.m.)</b>	<b>FEE</b>
Hourly Rental* — City Residents	\$60.00 per hour
Hourly Rental* — Non-City Residents	\$70.00 per hour
Daily Rental (12 Hours) City Residents	\$600.00
Daily Rental (12 Hours) Non-City Residents	\$700.00
Rental Deposit*	\$150.00
* <i>Deposit is refundable with an undamaged and cleaned return of facility. Premises must be vacated at the end of rental time. If customer stays past that time the deposit will be forfeited. Customer is not allowed to show up prior to rental time for set up unless approved by Heritage House manager.</i>	
<i>Note: wedding fee — See Sec. 26-23</i>	

Approved Neighborhood Civic Association Meetings at the Heritage House <i>(Meeting can be held on the first Tuesday or first Thursday and every Friday of each month)</i>	No charge for use
<i>Note: 4-hour minimum required for all rentals on Friday, Saturday and Sunday and any rentals after 6:00 p.m. Monday through Thursday.</i>	
<i>Discount Available: 25% off hourly rate for recurring meetings of 6 or more every 12 months</i>	

SECTION 2. That Chattanooga City Code, Part II, Chapter 2, Section 26-35, be amended by adding the following:

**Sec. 26-35. – Van Use by City Departments.**


There is a \$100.00 per day van use fee for each department. The Department requesting a driver must pay for driver.
