

RESOLUTION NO. 24389

A RESOLUTION AUTHORIZING TENNESSEE AQUARIUM TO USE TEMPORARILY THE CITY'S RIGHT-OF-WAY AT 1 BROAD STREET TO INSTALL SIX (6) BANNERS ON THE EAST WALL OF THE TENNESSEE AQUARIUM EXPANSION BUILDING AND TEN (10) PEDESTRIAN DIRECTIONAL SIGNS IN THE PLAZA AROUND THE AQUARIUM, AS SHOWN ON THE DRAWINGS ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Tennessee Aquarium (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily the City's right-of-way at 1 Broad Street to install six (6) banners on the east wall of the Tennessee Aquarium expansion building and ten (10) pedestrian directional signs in the plaza around the aquarium, as shown on the drawings attached hereto and made a part hereof by reference.

BE IT FURTHER ORDAINED, That said temporary usage shall be subject to the following additional conditions:

1. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.
3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.

INDEMNIFICATION AGREEMENT

This Indemnification Agreement is entered into by and between THE CITY OF CHATTANOOGA, TENNESSEE (hereinafter the "City"), and TENNESSEE AQUARIUM (hereinafter "Temporary User"), this the 5th day of April, 2005.

For and in consideration of the granting of the temporary usage of the City's right-of-way at 1 Broad Street to install six (6) banners on the east wall of the Tennessee Aquarium expansion building and ten (10) pedestrian directional signs in the plaza around the aquarium, as shown on the drawing attached hereto and made a part hereof by reference, the receipt of which is hereby acknowledged, Temporary User agrees as follows:

1. Temporary User will defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.

2. Temporary User will vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User will restore the property to its original condition when it is returned to the City.

3. Temporary User will provide adequate access for maintenance of any utilities located within the easement.



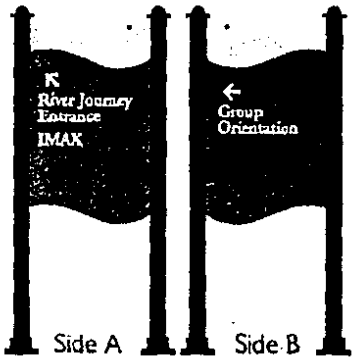

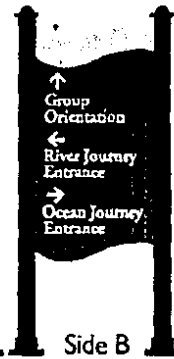

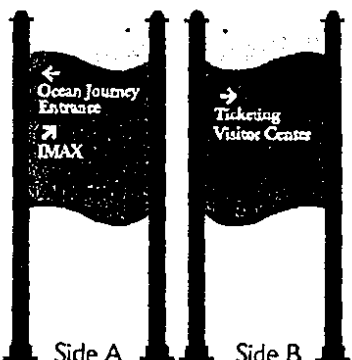

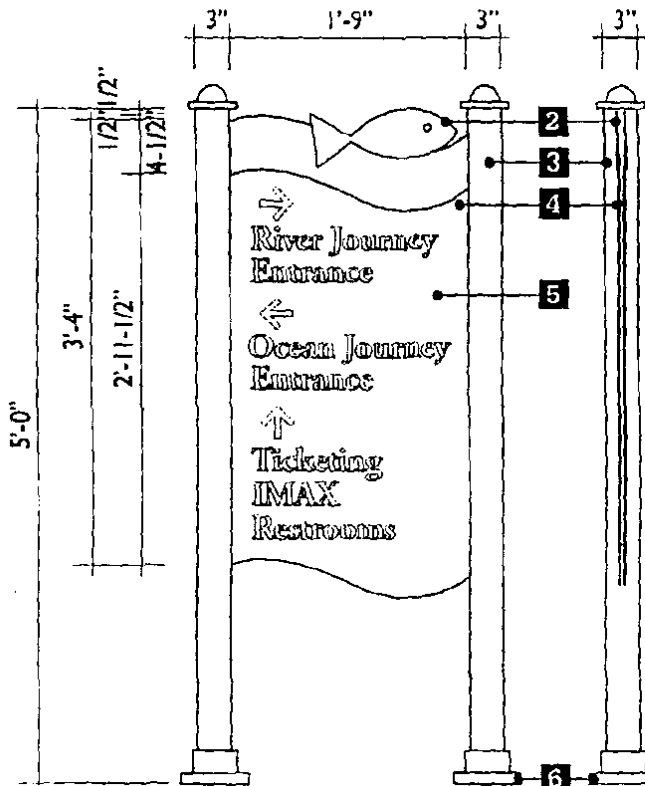

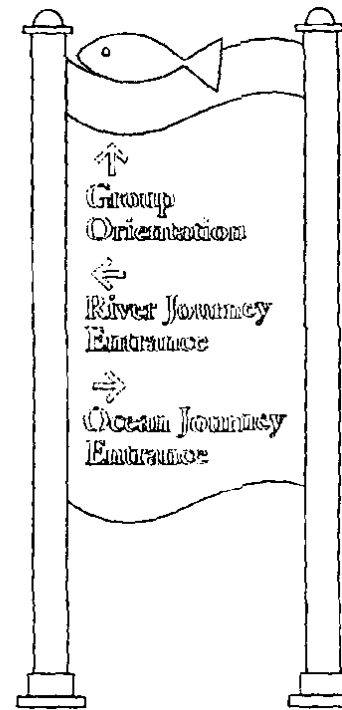


Front Elevation - Color

- 1** GENERAL NOTE: Sign contractor to coordinate with General Contractor for construction and installation of all sign components, routing of electrical access, electrical hookup, lighting, and foundations. All supports and attachments to be engineered to meet all applicable structural and windload requirements. All drawings to be stamped by structural engineer licensed in the state of Tennessee.
- 2** Fish Icon: .125 aluminum panel cut to shape as shown, primed and painted on all exposed surfaces to match P-4. Eye painted to match P-5. Icon is double-faced with shapes mounted back-to-back. Icon shapes are attached to sign face panel with concealed studs and permanent adhesive.
- 3** Support Post: 3" diameter round aluminum post with aluminum top cap as shown. Support post has aluminum mounting bracket welded to side to allow attachment of removable front and back side panels (see Sheet G1.07 for construction details). Support post assembly primed and painted on all exposed surfaces to match P-1.

- 4** Sign Panel: .125 aluminum panel cut to shape as shown, primed and painted on all exposed surfaces to match P-3, with top band painted to match P-2. Sign is double-faced with sign panels mounted back-to-back. Front and back panels are mechanically attached to support post mounting bracket with tamper-resistant fasteners to allow for removal and replacement (see Sheet G1.07 for construction details). Panel material alternate: cast fiberglass.
- 5** Arrows and text are applied die-cut vinyl to match V-1. Typestyle: Adobe Garamond Bold. Note: text shown for illustration only; see Sheet G1.08 for copy layouts by location.
- 6** Base: Base assembly is .125 aluminum with corners and edge seams welded and ground smooth to appear seamless. Base assembly primed and painted on all exposed surfaces to match P-1. Footing: Support post and base assembly attached to below-grade concrete footing as specified by the City of Chattanooga Department of Traffic Engineering. Note: all below-grade footing locations are to be coordinated with City Departments of Traffic, Engineering, and Public Works. Note: see Sheet G1.07 for construction details.
