

RESOLUTION NO. 25834

A RESOLUTION APPROVING THE ACCEPTANCE AND DISTRIBUTION OF FISCAL YEAR 2009-2010 COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME INVESTMENT PARTNERSHIP ACT FUNDS FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AND PROGRAM INCOME, ALL TOTALING APPROXIMATELY THREE MILLION EIGHT THOUSAND DOLLARS (\$3,008,000.00), AND FURTHER AUTHORIZING ACCEPTANCE, AND IF AWARDED, THE DISTRIBUTION OF EMERGENCY SHELTER GRANT FUNDS FROM THE TENNESSEE HOUSING DEVELOPMENT AGENCY (THDA) IN THE APPROXIMATE AMOUNT OF EIGHTY-FIVE THOUSAND DOLLARS (\$85,000.00) AS SHOWN MORE FULLY HEREINBELOW.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby approved the acceptance and distribution of Fiscal Year 2009-2010 Community Development Block Grant funds and HOME Investment Partnership Act funds from HUD and program income, all totaling approximately \$3,008,000.00 as shown on the schedule below, subject to approval by HUD:
