The vehicle was a gray sedan and only occupied by the driver. The vehicle traveled into the River Park.

I was able to make contact with the individual in a parking area of the park. Seth MARLER stated that he thought it would be funny to play that type of propaganda music while traveling in front of the NOSC. He freely supplied his DL and did not too nervous during our interaction. MARLER was following his cousin to a party that was being held at the #1 pavilion within the River Park. This pavilion is in a completely different area of the River Park.

The cousin stated that MARLER has recently been more interested in videos and music containing this type of ISIS media.

MARLER did not have any warrants at the time of the interaction. There was no history found on MARLER at the time of the interaction. He left the area of the NOSC to find pavilion #1 within the River Park.
