The female that Ms. Blackwell pointed out as staying with Mr. Caldwell then approached me. The female claimed that I was harassing them in their apartment. I explained that we were there because a person called in to report her ex-boyfriend harassing her. The female speaking to me said, "That must be Brianna." I never mentioned the reporting party's name, nor was Ms. Blackwell's apartment in view for this female to see who called me to report the matter. Because of the totality of the statements gathered, I warned the female talking to me that she, nor anyone else in her apartment should go over to Ms. Blackwell's apartment.
